MESSAGE FROM THE DIRECTOR

A core purpose of the V&A is 'to enrich people's lives and contribute to Britain's success as a creative nation'. Research on the Museum's holdings plays a central role in our endeavours to fulfill that mission, building on the V&A's reputation as the founding collection of the decorative arts in Britain and one of the world's leading resources for expertise in the field.

The V&A strives to foster an active research culture. developing authoritative and accessible outcomes through its galleries, exhibition and publication programmes and its website. It also encourages its staff to contribute to all areas of research, theoretical and practical, at the highest level.

This Report, the ninth in a series stretching back to 1990, captures the scope of such activity and demonstrates the V&A's continuing commitment to lead in object-focused research in the histories of art, design and the decorative arts; to stimulate In a return to the annual format, the next Report debate about its subject areas; and to encourage new approaches. Readers will see that research is undertaken by almost all members of the Collections, Conservation and Learning and Interpretation Departments, often in collaboration with external partners from other museums and with peers in the University sector.

The Museum has pioneered partnerships with Higher Education Institutions through its:

Exchange programmes with Sussex University and the Yale Centre for British Art;

Long-standing shared postgraduate courses with the RCA:

Participation in the AHRC-funded Collaborative Doctoral Scheme and other major research projects;

Its joint fellowship schemes (with, for example, the University of Brighton, the University of the Arts London, Buckinghamshire Chilterns University College and the University of the West of England).

Besides supporting the Museum's Contemporary Programme with its focus on present cultures and the creative industries, research also provides a critical underpinning for broader strategic initiatives, ensuring that major exhibition and gallery re-developments are built on authoritative scholarship.

This year, for the second year running we provide a fuller commentary on the processes and developing ideas that accompany research activity at the V&A through the publication of the V&A Research Bulletin, which is designed to complement the more quantitative approach of the Reports. We are also planning to launch a new on-line Research Journal, providing an innovative space for the posting of articles and reviews by V&A staff and others, focusing on the Museum's history, collections and activities
